of the Joint Commissioner, HR & CE Admn.Dept., Villupuram in dismissing
the O.A.3/2012 filed to modify the scheme.**

The above Miscellaneous Petitions came up for hearing before me on 29.9.2015 in the presence of Thiru. R.Thiagarajan, Counsel for the appellant, Thiru.D.Kanagasundaram Counsel for the Respondents 6,15,16 and 18 to 20 and Thiru.B.Kesavan Counsel for the 1st respondent. Upon hearing their arguments and having perused the connected records the following order is passed.

Order

The above Miscellaneous Petitions filed seeking stay of the order dated 10.6.2015 passed by the Joint Commissioner Villupuram in O.A.No.3/2012 and to stay the elections scheduled to be held to elect the trustees.

2. I heard Thiru. R.Thiagarajan, Counsel for the appellant, Thiru.D.Kanagasundaram Counsel for the Respondents 6,15,16 and 18 to 20, Thiru.B.Kesavan Counsel for the 1st respondent and perused the relevant records.

3. The Board of Trustees of the suit temple have been elected as per the scheme framed in O.S.No.42/1933 by the District Court, Cuddalore and modified by the Deputy Commissioner, Chennai in O.A.144/1968 by order dated 5.3.1977. As per the said scheme Trustees have been elected so far. The Appellant herein filed Original Application before the Joint Commissioner in the year 2010 to modify the scheme by incorporating suitable provision to provide voting right to the major women belonging to the 7 Karais. The said Original Application was dismissed by the Joint Commissioner, Villupuram by order dated 10.6.2015. The appellant filed appeal petition before this forum under Section 69(1) of the HR&CE Act. The appellant seeks stay of the election pending disposal of the appeal petition but it was strongly opposed by the respondent.

4. As per the scheme provisions Trustees have been elected from the year 1933 onwards without any hindrance. Further after lapse of several decades the appellant seeks modification of scheme to provide voting rights to the women. The same was rejected by the Joint Commissioner. Further

any order to be passed in this appeal petition will be an appealable one. Hence disposal of the appeal petition will not put an end to the litigation. As contended by the respondents granting of stay will amount to allowing of the appeal petition. Further during the pendency of the modification petition the Trustees were elected as per the scheme provision. Hence there is no justification to stay the impugned order and the election of Trustees. Accordingly the miscellaneous petitions are hereby rejected.
